This is an Agreement between Bed Bath n' Bonz Inc. and the pet owner. Whose signature appears below (hereinafter called "Owner").

1. Owner agrees to pay the rate for pet care provided in effect on the date pet is checked into Bed Bath n' Bonz, Inc.
  - a.) Including any and all late check-out fees: Check out times are Mon-Sat 12:00p or by 3:00p if (*bathed or groomed*) and by 3:00p on Sundays. Early drop offs will result in a ½ day charge if before 12:00p. Facility Hours are Mon-Sat 8-6, Sun 1-5. Owner Initials \_\_\_\_\_

  - c.) If my dog arrives at Bed Bath n' Bonz with fleas I will pay for a flea bath and treatment. Owner Initials \_\_\_\_\_

2. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the period said pet is in the care of Bed Bath n' Bonz, Inc.
3. Owner further agrees that the pet shall not leave the facility until all charges due are paid by Owner or proper payment arrangements are agreed upon by both parties.
4. By signing this Agreement and leaving pet with Bed Bath n' Bonz, Inc., Owner certifies to the accuracy of all information given about said pet. Bed Bath n' Bonz, Inc. reserves the right to deny admittance to Owner's pet for any reason at any time.
5. Bed Bath n' Bonz, Inc. shall exercise reasonable care for the pet delivered by the Owner to the pet care provider. If interactive daycare is provided, Owner recognizes and accepts potential risks involved in such activity. It is expressly agreed by Owner and pet care provider that Bed Bath n' Bonz's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$400.00 per animal admitted. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the pet care provider, to include payment of costs for injury to staff or other animals or damage to facilities caused by the pet.

6. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.

7. Owner specifically represents to Bed Bath n' Bonz, Inc. that, to Owner's knowledge, the pet has not been exposed to any contagious diseases within a thirty-day period prior to check-in. During the period of this Agreement, Owner also agrees to notify Bed Bath n' Bonz, Inc. of any known exposure of pet to a communicable disease and hold pet out of attending Bed Bath n' Bonz, Inc. until pet is symptom-free for a minimum of 3 days or with written veterinary clearance. Owner further agrees to maintain currency of vaccinations as required by Bed Bath n' Bonz, Inc. policy.

8. All Charges incurred by Owner shall be payable upon pick-up of pet, or when billed by Bed Bath n' Bonz, Inc. at address listed on contract. Bed Bath n' Bonz, Inc. shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from services provided by Bed Bath n' Bonz, Inc. The Owner hereby agrees that in the event the charges are not paid when due in accordance with this contract, Bed Bath n' Bonz, Inc. may exercise its lien rights upon ten days written notice given by Bed Bath n' Bonz, Inc. to Owner by certified mail to address shown on contract. Bed Bath n' Bonz, Inc. may dispose of pet for any and all unpaid charges, at private or public sale, in the sole discretion of Bed Bath n' Bonz, Inc., and Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of pet care or other charges delinquent, plus costs of sale, then Owner shall be liable to Bed Bath n' Bonz, Inc. for the difference. All monies realized by Bed Bath n' Bonz, Inc. at such sale, over and above the charges due and costs of sale, shall be paid by to Owner.

9. If pet becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, Bed Bath n' Bonz, Inc., in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner.

10. Bed Bath n' Bonz is not responsible for lost or damaged items. All personal belongings must be labeled prior to pets stay.

#### WELLNESS CARE PROGRAM

Your Pet is covered by the Wellness Program. This program will cover veterinary care, up to \$400.00, should it be required during the stay or within (10) days after Bed Bath n' Bonz, Inc. relinquishes care, custody or control of the Pet to the Pet Owner.

#### PROGRAM LIMITATIONS:

This program does NOT cover the following items as these are beyond our control:

- CANINE COUGH
- Age related illness or disease- kittens/puppies
- Bloat
- Injury, illness or death when pets, sharing a suite at owner's request, take action against one another
- Injury, illness or death resulting from whelping or pregnancy
- Injury, illness or death resulting from war, nuclear radiation, contamination or any act of God

#### PROGRAM TERMS and CONDITIONS

This coverage shall be effective and binding on Bed Bath n' Bonz, Inc. only if the Pet Owner complies with each of the following conditions.

1. In the event that the Pet requires on-going treatment after its owner has taken possession of the pet, the Pet Owner hereby agrees to authorize the Pet's veterinarian to forward a copy of the diagnosis and treatment history to Bed Bath n' Bonz, Inc. Such records may be required before any claims are paid.
2. Reimbursement under this certificate shall be Bed Bath n' Bonz Inc.s' maximum liability. Any monies paid by Bed Bath n' Bonz, Inc. to veterinarians and hospital will be deducted from and shall not be in addition to the maximum coverage limits.

Pet Owners Initials

This Agreement contains the entire agreement between the parties. All terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Bed Bath n' Bonz, Inc.
